Advocate Aman Wadud of the Gauhati High Court, vide his Complaint dated 15.02.2016, has accused Shri Anjan Bora, Deputy S.P, 23<sup>rd</sup> AP (IR) Bn, Manja, Karbi Anglong, of making certain Deliberate and Malicious statements in Social Media (Facebook) on 24.01.2016 and 08.02.2016 respectively against and hurting the sentiments of the Muslim Community which are prejudicial to maintenance of communal harmony and detrimental to Law and Order situation besides being contrary to the constitutional provision relating to Right to Freedom of Religion. The circumstances besetting with the above issue have been detailed in the complaint.

Cognizance of the instant case has been taken in view of the above allegation levelled against the said police officer who had been in the meantime reportedly placed under suspension by the Government of Assam in the Home Department.

Issue Notice with a copy of the complaint and the copies each of the enclosed documents to the Commissioner and Secretary to the Government of Assam, Home and Political Department, Dispur, to cause an appropriate enquiry to be conducted into the said allegation and submit the report thereof before this Commission within thirty days of receipt of the Notice.
